2 Course Description

This graduate course explores key issues in contemporary epistemology, focusing on the nature of knowledge and epistemic justification. We critically reassess the traditional definition of knowledge as justified true belief in light of the Gettier Problem. Challenging the common view that Gettier refuted this account, we examine recent theories suggesting the problem is a solvable paradox rather than a definitive refutation.

Extending into social epistemology, we investigate how social contexts shape our understanding of knowledge. Topics include testimony, collective belief, epistemic injustice, and communal practices in knowledge formation. By integrating individual and social perspectives, the course aims to demonstrate that justified true belief remains a robust account of knowledge.

3 Course Goals

This graduate course aims to equip students with a nuanced understanding of knowledge and justification in contemporary epistemology. Students will critically analyze the "justified true belief" model, grappling with the Gettier Problem and exploring its proposed solutions. By examining the interplay between individual and social dimensions of knowledge, including topics like testimony and epistemic injustice, students will develop the ability to critically assess and contribute to current debates surrounding knowledge.

You are expected to participate in class discussions regularly. Mere quantity of participation is not enough to do well on your participation grade, but relatively frequent participation is certainly advisable. I will call on people freely to ensure everyone participates.

4.4 Research Paper

Students will write one (1) argumentative paper of around 6000 words on a topic in epistemology. Topics will be provided. It will be possible for you to propose your own topic. However, before you pursue a topic different from the ones provided by the instructor, you must check with him whether the topic is appropriate.
